Price And Payment

- The Price shall be as indicated on invoices provided by the Seller to the Buyer in respect of Goods supplied.

If any of the Goods are damaged or destroyed prior to property in them passing to the Buyer, the Seller is
entitled, without prejudice to any of its other rights or remedies under these Terms and Conditions of Trade
(including the right to receive payment of the balance of the Price for the Goods), to receive all insurance
proceeds payable for the Goods. This applies whether or not the Price has become payable under the Contract.

Defect/Returns

The Buyer shall inspect the Goods on delivery and shall within five (5) days of delivery notify the Seller of any alleged defect, shortage in quantity, damage or failure to comply with the description or quote. The Buyer shall afford the Seller an opportunity to inspect the Goods within a reasonable time following delivery if the Buyer believes the Goods are defective in any way. If the Buyer shall fail to comply with these provisions, the Goods shall be conclusively presumed to be in accordance with the terms and conditions and free from any defect or

Default & Consequences Of Default
